Individual members maintain their personal status as voting members of the association, have separate listings in the NAFCM Directory, are able to participate in the NAFCM listserv, receive discounts on NAFCM publications and trainings, and have select access to NAFCM’s online clearinghouse and related resources. **Annual membership dues: \$30.**

Program Membership: This category is for centers, programs, or agencies providing community dispute resolution and/or mediation services. Program members maintain their organization’s status as voting members of the association, have separate listings in the NAFCM Directory, are able to participate in the NAFCM listserv (up to five associated e-mail addresses), receive discounts on NAFCM publications and trainings, and have complete access to NAFCM’s online clearinghouse and related resources. **Annual membership dues are based on the program’s annual operating budget, as detailed below.**

State association members maintain their organization’s status as voting members of the association, have separate listings in the NAFCM Directory, are able to participate in the NAFCM listserv, receive discounts on NAFCM publications and trainings, and have complete access to NAFCM’s online clearinghouse and related resources. **Annual membership dues are based on the association’s annual operating budget as detailed above.**

Supporter of Community Mediation: This category is for those who wish to support NAFCM in its mission to advance the field of community mediation, but who are not directly involved in or wish to receive the benefits associated with serving or operating a community mediation center. Annual financial support for NAFCM is appreciated at multiple levels.
